IN RETURN FOR THE BENEFITS THAT I WILL RECEIVE FROM MY ULTRALIGHT INSTRUCTION, I AGREE THAT:

- 1) I ASSUME ALL RISKS OF INJURY. DEATH OR DAMAGES AS MAY OCCUR DURING SUCH INSTRUCTION, OR AS MAY BE DIRECTLY RELATED TO SUCH INSTRUCTION OR USE OF THE LAND.
- 2) I RELEASE MARK AND ANGELA ZABEL, MARK'S PARK & AIRFIELD AND MY INSTRUCTOR (WHOSE NAME IS SIGNED BELOW) FROM ALL CLAIMS THAT I MIGHT HAVE AGAINST MARK AND ANGELA ZABEL, MARK'S PARK & AIRFIELD AND MY INSTRUCTOR LISTED BELOW, FOR INJURY, DEATH OR DAMAGES RESULTING FROM MY PARTICIPATION IN SUCH INSTRUCTIONS AND USE OF THE LAND.
- 3) I WILL HOLD MARK AND ANGELA ZABEL, MARK'S PARK & AIRFIELD AND MY INSTRUCTOR LISTED BELOW, HARMLESS FROM ANY CLAIMS FOR INJUURY, DEATH, OR DAMAGES RESULTING FROM MY PARTICIPATION IN SUCH INSTRUCTION AND USE OF THE LAND.

I UNDERSTAND THAT THIS AGREEMENT SHALL APPLY EVEN IF THE INJURY, DEATH, OR DAMAGES RESULTS FROM MARK & ANGELA ZABEL, MARK'S PARK & AIRFIELD AND/OR MY INSTRUCTOR'S, ACTIVE OR PASSIVE NEGLIGENCE.
